ORDINANCE NO. 13-004

AN ORDINANCE ANNEXING REAL PROPERTY INTO THE CITY OF WILLIAMSBURG LOCATED IN WHITLEY COUNTY, KENTUCKY.

WHEREAS, annexation and subsequent development may provide economic and social benefits to the City of Williamsburg through the creation of housing, business and commercial enterprise, creation of construction and permanent jobs and expansion of the City's tax base; and,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLIAMSBURG, KENTUCKY, AS FOLLOWS:

SECTION I: That the corporate limits of the City of Williamsburg, Kentucky, as now established be extended so as to include the territory hereinafter described and to annex the property into the City of Williamsburg, Kentucky:
